1. GENERAL REGULATIONS

The **17th Tirnavia Ice Cup** will be conducted in accordance with the ISU Constitution and General Regulations 2024, the Special Regulations and Technical Rules Single and Pair Skating 2025 and the relevant ISU Communications. Participation in the 17th Tirnavia Ice Cup is open to all competitors who belong to an ISU Member (Rule 109, paragraph 1) and qualify with regard to eligibility according to Rule 102, provided their ages fall within the limits specified in Rule 108, paragraph 3 and they meet the participation, citizenship and residency requirements in Rule 109, paragraphs 1 through 5 and ISU Communication 2526 or any update of this Communication.

In accordance with [Rule 109](#) of the ISU General Regulations and ISU Communication 2526 all skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, must produce a Clearance Certificate. Passports of all skaters, as well as the ISU Clearance Certificate, if applicable, must be presented at the accreditation of the event for verification.

All participants accept that personal data are collected by the Organizing Committee (OC) and such data are stored and used by the OC, and when necessary, third parties, for the purposes only of, and to the extent necessary only in relation to facilitate their participation in the competition; personal data may include but will not be limited to full legal name as per national identity documents, address, date of birth, nationality, sex

3. ENTRIES

Entries by names must be sent **not later than Wednesday, October 15th, 2025, 11:59PM (local time)**

4. ENTRY FEE

With the entry to the competition, the entry fee must be paid **not later than Friday, October 17th 2025** as follows:

5. PLANNED PROGRAM CONTENT & MUSIC

The **PPC** (Planned Program Content) **must be entered** by the ISU Member or the Skater(s) through the **ISU Portal** in English using official ISU terminology.

All Competitors shall furnish competition **music** of excellent quality **on mp3 format** by **sending** the file(s) to tirnaviaicecup2018@gmail.com until **Monday, October 20th 2025**. Any other format will not be accepted. In accordance with Rule 343, paragraph 1, the title of the file must show the Competition segment, competitor's name, the nation, and the exact running time of the music (not skating time) including any starting signal.

Example: *JuniorWomen_SP_Surname-Name_SVK_2:48*

The skater is responsible for ensuring they hold all appropriate music licences. A list of titles, composers and orchestras of the music to be used for the Short Program and Free Skating Program must be entered on the ISU Portal. If music information is not complete and/or the music is not provided, accreditation will not be given.

In addition competitors must provide a **back-up drive** for each program at the side of the rink for immediate use.

6. MEALS, LODGING and TRAVEL EXPENSES

The Organizer will provide and cover the rooms and meals for Officials and Judges, beginning with dinner on October 31st until lunch on November 3rd. Travel expenses will not be reimbursed. Travel expenses will be paid only to the Referees, the Technical Specialists, Technical Controllers and Data/Replay Operators based on economy airfare. All Competitors, Coaches and Team Leaders have to bear their own expenses. All participants, except Referees and Judges on duty as well as the members of the Technical Panels on duty, have to pay for their own accommodation. 7. PRACTICE & DRAW

Practices will be available during the event. The detailed practice schedule will be available as soon as possible following the closing date for entries.

The opening draw for the order of skating will be held on **Thursday, October 30th 2025**. The exact place and time will be published in the official detailed schedule. Starting order for the free skating will be in reverse order of the results of the short program.

8. ARRIVAL OF PARTICIPANTS/TEAMS

The office of the organizing committee and the registration office will be located at the icerink and will be open every day during the competition. Participating teams are kindly asked to announce changes to their teams as early as possible but at the latest immediately after the arrival of the team. For further information please contact OC.

9. INSURANCE/LIABILITY

The Organizer assumes no responsibility for or liability with respect to bodily or personal injury or property damage incurred in connection incurred by Competitors and Officials.

10. RESULTS

The marking system (ISU JudgingSystem) as described in ISU Technical Rule Single and Pair Skating 2018, Rule 352 and Rule 353 (Determination and Publication of Results) will be used.

The results and any further information will be posted on the **'Sportity' channel 'TIC2025'**.

11. AWARDING

The three best placed Skaters/Couples in each event will be announced and honored. All participants will receive Diplomas.

12. MEETINGS FOR ISU EVENT OFFICIALS and JUDGES

The Initial Judges Meeting and Judges Draw will be held the first day prior to the first competition segment. All initial Technical Panel Meetings will be held during the first competition day and will be adjusted to the competition schedule of each discipline.

Officials and Judges are responsible to make their travel arrangements in order to be able to attend the respective meetings.
