September 19-20-21st 2025

The Italian Ice Sports Federation (FISG) has the honor and pleasure to invite you to the Bormio Cup Test Race OPEN which will be held at the Ice Rink Palaghiaccio Bormio – Via Manzoni – Bormio (SO) on September 19th to 21st 2025. The competition will be organized in accordance with the 2025 regulations of the International Skating Union and the conditions included in this announcement.

Entries

Entries are restricted to **only invited National Teams** whose skaters must have been born before July 1st 2010 (i.e. who have turned 15 before July 1st 2025). *Skaters belonging to national teams born after July 1st 2010 can be accepted sub judice provided they have a minimum qualifying times respecting World Cup 2025/2026 participation criteria.*

Club skaters not belonging to national teams can also be accepted **by invitation only** provided their best times on 500m skated in season 2023/2024 and subsequent are in line with qualifying times required by World Cup 2025/2026 participation criteria.

Entries should be made on www.shorttrackonline.info; final entries closing on Wednesday September 10th.

Invited Italian skaters must also be entered on fisgonline; deadline is also Wednesday September 10th.

Entry fee

An entry fee of Euro 90.00 must be paid for every athlete

Track

The track is an artificial refrigerated indoor ice surface with measures of 30x60 meters, boardless protective padding will be in place. The standard track 111,12 meters to the lap with measured curves of 8,50 meters will have 7 markers used to establish the curve. The length of the straight is 28,85 m. Besides the original track there will be 7 tracks set to preserve good ice conditions. For all tracks one finish line will be used.

Board and Lodging

Teams are responsible for their own accommodation.

Conditions of Contest

The competition will be raced according to a modified All-finals system, based on the number of competitors a repechage format may be used.

Distances

2x1500m, 2x500m, 2x1000m
3000m Relay (women), 5000m Relay (men), 2000m Relay (mixed gender)

Qualification

- Make-up of the first qualifying round of each of the first individual distance (eg. 1500m #1) will be based on the skater's Distance World Ranking at the end of the 2024/2025 world cup season; athletes without a 2024/2025 world ranking will then be seeded according to their best times on each distance skated in season 2023/2024 or later. The make-up of the first qualifying round of the second run of individual distances (eg. 1500m #2) will be based on the distance classification of the first run (eg. 1500m #1).
- Final results from each distance will be added to determine a combined distance classification. Points will be awarded according to a custom points system adapted to the number of entries.

Medical assistance

Doctor and paramedical personnel will be present on competition days. An ambulance will be on standby on site in case of any emergency.
