EGNA DANCE TROPHY 2025
INTERNATIONAL ICE DANCE COMPETITION
7 - 9 FEBRUARY EGNA/NEUMARKT, ITALY



1. GENERAL INFORMATION

The **Egna Dance Trophy 2025** Ice Dance International Competition will be conducted in accordance with the ISU Constitution and General Regulations 2024, the Special Regulations & Technical Rules Single & Pair Skating and Ice Dance 2024, and the relevant ISU Communications.

Participation in the **Egna Dance Trophy 2025** is open to all Competitors who belong to an ISU Member and qualify with regard to eligibility according to Rule 102, provided their ages fall within the limits specified in Rule 108, paragraph 3 a) and they meet the participation, citizenship and residency requirements in Rule 109, paragraphs 1 through 5 and ISU Communication 2526 or any update of this Communication.

In accordance with Rule 109 of the ISU General Regulations and ISU Communication 2526 all Skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate. Passports of all Skaters, as well as the ISU Clearance Certificate, if applicable, must be presented at the accreditation of the event for verification.

All competitors must be entered through their respective ISU Member Federation.

Rhythms, required elements and guidelines are those listed in ISU Communications 2630 and subsequent updates.

Duration: 2 min., 50 sec., +/- 10 sec

Free Dance:

In accordance with ISU Technical Rules Ice Dance 2024, Rule 710.

The required elements to be skated are those listed in ISU Communication 2630 and subsequent updates.

Duration: 3 min., +/- 30 sec.

ADVANCED NOVICE ICE DANCE

Pattern Dances:

In accordance with ISU Technical Rules Ice Dance 2024, Rule 711.

Pattern required elements and guidelines are those listed in ISU Communications 2625 and subsequent updates.

The following two (2) Pattern Dances are to be skated - Season 2024/25: Westminster Waltz and Tango

Couples shall provide their own music for all Pattern Dances.

Free Dance:

In accordance with ISU Technical Rules Ice Dance 2024, Rule 710.

Two (2) Pattern Dances are to be skated - Season 2024/25: Foxtrot, American Waltz, Kilian

These will be drawn before the first practice on site.

Couples shall provide their own music for all Pattern Dances.

Free Dance

In accordance with ISU Technical Rules Ice Dance 2024, Rule 710. The required elements to be skated are those listed in ISU Communications 2625 and subsequent updates.

Duration: 2 min. 30 sec +/-10 sec

Pattern required elements and guidelines are those listed in ISU Communications 2625 and subsequent updates.

Two (2) Pattern Dances are to be skated from the following: Season 2024/25: Swing Dance, Tango Fiesta and Rhythm Blues

These will be drawn before the first practice on site.

Couples shall provide their own music for all Pattern Dances.

Free Dance

In accordance with ISU Technical Rules Ice Dance 2024, Rule 710. The required elements to be skated are those listed in ISU Communications 2625 and subsequent updates.

Duration: 2 min., +/- 10 sec

3. ENTRIES

All Entries must be made by the ISU Member concerned based on the regulations for the ISU Technical Rules 2024 and respective ISU Communications.
All entries for the "Egna Dance Trophy 2025" must be done through the ISU Online Registration System (ORS) by the deadline indicated. Declarations will need to be uploaded to the ORS as well.

ENTRIES OF COMPETITORS

The OC reserves the right to limit the number of entries per category.

The Entries by names must be made via ISU Online Registration System (ORS):

and will be submitted via the ORS simultaneously to the OC.

Deadline for entries: **Thursday January 8, 2025, 20.00 local time Egna/Neumarkt ITALY**

All skaters will need to exist in the ISU ORS to be entered.

ENTRIES OF JUDGES

Each participating ISU Member has the right to nominate one judge and one substitute judge with at least the qualification "Judge for International Competitions".

In case of too many nominated judges, the organizer will draw the panel of judges immediately after the closing date for the entries. The confirmation of the list of judges will be announced in due time.

The Entries of Judges must be made via the ISU Online Registration System (ORS) not later than: **Thursday January 8, 2025, 20.00 local time Egna/Neumarkt ITALY**

ENTRY FEE

All entries sent after January 8, 2025 will be declared "late entries."

For all the nominated Referees, the Technical Panel (Technical Controllers, Technical Specialists, Data & Replay Operators) and Judges participating in the Competition the Organizer will provide accommodation and meals beginning with dinner on Thursday, February 6, 2025, through breakfast on Sunday, February 9, 2025. Please consider it may be necessary to leave on Monday morning. In this case meals will be provided till breakfast on Monday, February 10, 2025. Should any of the above-mentioned persons arrive at the hotel before or stay longer than the period described above, their room costs and expenses will be the responsibility of the individual and must be paid on arrival.

All Referees, the Technical Panel (Technical Controllers, Technical Specialists, Data & Replay Operators) and Judges taking part in the Competition are requested to announce the flight/train numbers, dates and times of arrival and departure or any other information concerning transportation to the Organizing Committee as soon as possible but no later than January 15, 2025, to organize check-ins and check-outs. Please note that the OC will not organize transfers for the judges, who must arrange them with their federations.

The hotel is 1,5 Km. far from the Ice rink.

Travel expenses to/from Egna, transfer costs to/from the Official Hotel and Airport will NOT be covered by the organizer.

5. TRANSPORTATION

The nearest airport is Verona Valerio Catullo International Airport (132Km).

Please check <https://www.aeroporto.verona.it/en/transport.html> for further information on how to travel from and to the airport.

The nearest train stations are Egna train station (2,6Km) and Bolzano train station (25Km).

The Organizing Committee does not provide any transportation to the participants.

Travel expenses to/from Egna, transfer costs to/from the Official Hotel and Airport will NOT be covered by the organizer

6. ACCREDITATION

Accreditation will be at the Ice Rink starting from **February 6, 2025** before the first official practice.

All the Couples are requested to present a valid passport as per ISU rules at the time of registration.

In accordance with the ISU Directive please note that at the time of registration (Entry fee, music) we must copy and file the passport of the Skaters.

Accreditation as a Team Member will be given to all entered Judges, Competitors and one Team Leader per ISU Member, one Coach per couple, a maximum of two Team Officials of ISU Members (including the Member President), provided that they are Council Members, Technical Committee Members or Members of the Head Office of their Federation and a maximum of two medical persons.

Accreditation will only be granted to persons in those various functions, if officially entered and named through their ISU Member. The ISU Member certifies with the signed entry form the indicated functions within the team of all team members. Any misuse of any function will be sanctioned by the ISU/OC.

Accreditation will be given to appointed Event Officials and Guests.

Chaperones will not receive accreditation.

7. DRAW

The starting order will be drawn by the Italian Federation FISG on **Thursday, February 6, at 17.30** at the ice rink. No draw after Rhythm Dance and Pattern Dance. Starting order for Free Dance will be according to the reverse of the Rhythm Dance and Pattern Dance results.

8. MUSIC/PLANNED PROGRAM CONTENT

Music has to be sent by e-mail to music.egna@gmail.com.
PPC sheets must be sent by e-mail to music.egna@gmail.com.

All files must show the competitor's name, the nation and the exact running time of the music. Each program (Pattern Dance, Rhythm Dance, Free Dance) must be saved in a separate file and should be labelled with the name of the ISU Member, name of the category, segment and the names of the competitors.

Example: SUI_ID_FD_MUSTERMANN-Erika_MUSTERMANN-Max

The ISU Member is responsible for submitting their competitor's music as direct attachment to an email to the Organizing Committee (music.egna@gmail.com) until Thursday January 30, 2025 (one week prior to competition).

Please note: some music files might exceed the size of a regular email. In this case, an email-based transfer service which allows to send large files could be used to send the file to the OC.

The music files must be sent as WAV or MP3 file formats. Any other format is not acceptable. Files in MP3 format may have a significant difference in the music quality when reproduced. The Organizing Committee in this case is not responsible if the music quality would be insufficient.

Each Competitor must have an own back-up drive (USB Stick) for each program in the format of a WAV or MP3 file (CD will not be accepted by the OC).

If music information is not complete and/or the music is not provided, accreditation will not be given.

9. RESULT

The marking system (ISU Judging System) as described in ISU Technical Rule Single & Pair Skating 2024, Rule 352 and Rule 353 (Determination and publication of results) will be used.

10. PRESENTATION OF MEDALS

The three best placed Couples in each event will be announced and honored.
The exact time of the Awarding Ceremonies will be announced in the detailed schedule in due time.

11. EXHIBITION

No Exhibition Gala is scheduled to take place.

12. INSURANCE / LIABILITY

The Organizer assumes no responsibility for or liability with respect to bodily or personal injury or property damage incurred in connection by Competitors and Officials. Furthermore, the OC is not responsible for any contagion that occurs at the event outside of compliance with the prevention protocols implemented.

In accordance with Rule 119, it is the sole responsibility of each Member participating in the Egna Dance Trophy 2025 to provide medical and accident insurance for their athletes, officials and all other members of the Member's team. Such insurance must assure full medical attendance and also the return to home country by air transport or by other expeditious means of the ill or injured person.
