WELCOME

GENERAL REGULATIONS

The **Volvo Open Cup 54**th will be conducted in accordance with the ISU Constitution and General Regulations 2024, the Special Regulations and Technical Rules Single & Pair Skating and Ice Dance 2024, and the relevant ISU Communications.

Participation in the **Volvo Open Cup 54th** is open to all Competitors who belong to an ISU Member, and qualify with regard to eligibility according to Rule 102, provided their ages fall within the limits specified in Rule 108, paragraph 3. a) and they meet the participation, citizenship and residency requirements in Rule 109, paragraphs 1 through 5 and ISU Communication 2526 or any update of this Communication.

In accordance with Rule 109 of the ISU General Regulations and ISU Communication 2526 all Skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate. Passports of all Skaters, as well as the ISU Clearance Certificate, if applicable, must be presented at the accreditation of the event for verification.

All competitors must be entered through their respective ISU Member Federation. Clubs registered at ISU Members Federations can participate in competition or Invited clubs ONLY. The OC can have a final design about over quota for any club/country/federation or refuse to accept the entry (full or partially). APPOINTED EVENT OFFICIALS / ENTRTIES OF JUDGES

This Volvo Open Cup 54th. event will follow the principles of International Skating Union for appointing the event officials. The members of each individual Technical Panel, Referee and Judges will have at least the qualification "International".

Each participating ISU Member may nominate one (1) Judge with the qualification "Judge for International competitions" or "ISU Judge" per discipline, double duty Judges are very welcome. We cover hotel`s/meal/pocket money ONLY for Judges who are acting in several panels except those where own federation skaters are presented

The Panels of Judges will consist of five (5) Judges in all panels.

In case of too many nominated judges the organizer will draw the panel of judges immediately after the closing date for the entries. The result of such draw will be communicated to all ISU Members involved in writing immediately after the conclusion of such draw.

PRACTISE

You have book in advanced till **December 6th, 2024**. Extra fee: 25.- Euro / 25 min. person, no music. The detailed schedule will be issued at the time of registration

MUSIC / PLANNED PROGRAM CONTENTS

All competitors shall furnish by December 20th, 2024 competition music of excellent quality via email to musicvolvocup@gmail.com

The music files must be sent as MP3, M4A or WAV format. Any other format is not acceptable. In accordance with Rule 343 paragraph 2. must have Competitor's name, Member's name and the exact running time of the Music (not skating time) including any starting signal and must be submitted at the time of registration.

Each Competitor must have an own back-up drive (USB Stick) in the format of a MP3, M4A or WAV format.

If music information is not complete and music not provided, accreditation will not be given.

With the entry forms, the "Program Content Sheet" must be returned to the Organizing Committee. (Kristal_ice@hello.lv), It is mandatory that the Program Content Sheet be completed precisely by each skater/couple in English using the proper terminology.

Starting orders for the second segment FS will be reverse order of the result of SP.
