Decisions of the Council

The ISU Council met online on May 8, 2024.

The following were among the decisions taken by the Council during the meeting.

1. ISU European Figure Skating Championships 2025

Due to unforeseen circumstances, the Croatian Skating Federation will be unable to host the ISU European Figure Skating Championships 2025 on January 20-26, 2025. The Council therefore decided to reopen bid applications for these Championships. ISU Members interested in applying should email mayor@isu.ch or entries@isu.ch to receive the necessary application forms and current ISU Memorandum for hosting ISU Figure Skating Championships. The deadline for applications is **May 24, 2024** latest.

2. Junior Grand Prix Season 2024/25

Following the withdrawal of the Fédération Française des Sports de Glace from hosting an event of the 2024/25 Junior Grand Prix in Epinal, the Council allotted the event to Wuxi, China. The ISU Junior Grand Prix calendar season 2024/25 will therefore be as follows:

August 28-31, 2024	Riga / LAT (including Pair Skating)
September 4-7, 2024	Ostrava / CZE (including Pair Skating)
September 11-14, 2024	Bangkok / THA
September 18-21, 2024	Istanbul / TUR (including Pair Skating)
September 25-28, 2024	Gdansk / POL (including Pair Skating)
October 2-5, 2024	Ljubljana /SLO
October 9-12, 2024	Wuxi / CHN

3. ISU Grand Prix of Figure Skating Final 2024 – change of venue

The Council accepted the request of the Fédération Française des Sports de Glace to change the venue of the ISU Grand Prix of Figure Skating Final (Junior and Senior) 2024 to Grenoble, FRA (formerly Orléans, FRA).

4. Athletes Commission member of the Council

Athletes Commission Chair Eric Radford, who is the Athletes Commission member of the Council, has temporarily stepped down as a Council member for the period during which the appeal against the ISU in which he is named as an appellant is pending at CAS. During this time, the Vice Chair of the Athletes Commission, Douwe de Vries, will attend Council meetings in Eric Radford's place in order to continue the representation of the Athletes' voices in the discussions and decision-making processes of the Council.

5. Next Council meetings

The Council agreed to meet again as follows:

- June 8-9 and June 15-16, 2024 in Las Vegas, USA, on the occasion of the 59th ISU Congress.
- September 27-29 2024 in Lausanne, Switzerland.

6. Other matters discussed

The Council also considered and discussed other items including, but not limited to:

- Preparations for the ISU Congress 2024
- The 2023 audited financial statements and budget 2024-2026 preparations.
- Various legal matters.
